



## PRESS RELEASE

As part of the share buy-back program authorized by the Shareholders' meeting of 22 April 2014, it is noted that ASTM S.p.A. acquired, in the period from 26 January to 30 January 2015 included, n. 11,530 of the Company's ordinary shares (equal to 0.013% of the share capital), at an average price of € 10.9675 per share for a total amount of about € 126.46 thousands.

Since the start of the share buy-back, ASTM S.p.A. acquired a total of n. 621,050 own shares (corresponding to 0.71% of the share capital) for a total amount of € 6.47 millions.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 4,274,903 own shares (4.86% of the share capital) of which n. 4,253,403 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
