As part of the share buy-back program authorized by the Shareholders' meeting of 22 April 2014, it is noted that ASTM S.p.A. acquired, in the period from 29 September to 3 October 2014 included, n. 66,422 of the Company's ordinary shares (equal to 0.075% of the share capital), at an average price of € 10.3809 per share for a total amount of about € 689.5thousands.
