PRESS RELEASE

As part of the share buy-back program authorized by the Shareholders' meeting of 22 April 2014, it is noted that ASTM S.p.A. acquired, on 22 August 2014, n. 11,300 of the Company's ordinary shares (equal to 0.01% of the share capital), at an average price of € 10.30 per share for a total amount of about € 116 thousands.

Since the start of the share buy-back, ASTM, S.p.A. acquired a total of n. 176,154 own shares (corresponding to 0.20% of the share capital) for a total amount of € 1.98 millions.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 3,830,007 own shares (4.35% of the share capital) of which n. 3,808,507 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
