(l'"**Emittente**"), corrispondenti al 5% del capitale sociale dell'Emittente, resa nota in data 13 giugno 2019 ai sensi dell'art. 102, comma 1, del TUF e dell'art. 37 del Regolamento Emittenti, ASTM comunica, in conformità a quanto previsto dall'art. 41, comma 2, lett. c) del Regolamento Emittenti, di avere acquistato sul mercato, in data odierna, n. 110.000 azioni dell'Emittente (ISIN: IT0003201198) a un prezzo medio ponderato pari a Euro 15,49.
