

## ASTM SHAREHOLDERS' MEETING APPROVES THE 2023 ANNUAL REPORT AND APPOINTS THE NEW BOARD OF DIRECTORS

### ANGELINO ALFANO AND UMBERTO TOSONI CONFIRMED AS CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Tortona, April 23<sup>rd</sup>, 2024. The **Shareholders' Meeting** of **ASTM S.p.A.** ("ASTM" or the "Company"), one of the leading international infrastructure players in the management of motorway concessions, the design and implementation of major works and applied mobility technology, was held today.

The Shareholders' Meeting approved the **Annual Report** for the year ended on **31<sup>st</sup> December 2023**, which shows a profit of €18.9 million and took note of the **Consolidated Financial Statements** for the year 2023 which recorded a turnover of more than €4 billion, an EBITDA of €1,888.6 million and a net profit of €188.4 million, as well as the **Consolidated Non-Financial Statement** for 2023.

The Shareholders' Meeting also confirmed **Angelino Alfano** as Chairman and **Franco Moschetti** as Vice-Chairman of the Company.

The new Board of Directors, which met today at the end of Shareholders' Meeting, confirmed **Umberto Tosoni** as CEO of the Company.

The Board, which will be in office for three fiscal years and thus until the approval of the financial statement as of 31<sup>st</sup> December 2026, consists of the following 9 members:
